#### I. Introduction

#### CWI Works (CWI)

60+-year-old 501(c)(3) national nonprofit

Joint largest Senior Community Service Employment Program (SCSEP) National Grantee and continuous national grantee for past 59 years

Headquartered in Silver Spring, MD

Work with a national network of subgrantees organizations to operate SCSEP in 12 states

# Introduction (cont'd)

#### **ALABAMA**

CWI is the largest SCSEP national grantee in Alabama

CWI has served various parts of Alabama since 1972

Currently, CWI partners with nine (9) organizations in the state.

CWI is currently operating SCSEP services directly in the counties in this RFP.

# II. Request for Proposal (RFP)

CWI is seeking a qualified organization to administer its Senior Community Service Employment Program (SCSEP)

SCSEP is Title V of the Older Americans Act

Only federally-sponsored employment and training program targeted specifically to low-income older individuals who want to enter or re-enter the workforce

Multiple missions include promoting useful opportunities in community service job training and moving SCSEP jobseekers to unsubsidized employment, where appropriate

# II. RFP (cont'd)

#### SCSEP jobseekers...

Are eligible individuals 55 or older, unemployed, have participated on SCSEP for less than four years, and earn less than 125% of Federal Poverty Guidelines and want or need to re-enter the workforce

Paid federal, state or local minimum wage (whichever is higher)

For work experience at "host agencies" -501 (c)(3) nonprofit or government training sites

Typically 20 hours per week

# III. Roles & Responsibilities

#### <u>Subgrantee</u>

Employ at least a full-time project director for every 60 modified authorized positions and other personnel necessary for programmatic and financial administration and supervision of SCSEP. Since there are 36 modified authorized positions with this RFP, we are expecting our subgrantee to provide at least .6 FTE for direct service staffing.

Recruit and enroll eligible applicants

Select appropriate host agencies

Promote necessary linkages and partnerships

Comply with SCSEP regulations and policies

Meet performance goals outlined in Sponsor Agreement

# III. Roles & Responsibilities (cont'd)

#### • <u>CWI</u>

Provides training, guidance, coaching on all aspects of program and financial administration, performance, data collection and SCSEP regulations and policy

Provides technical assistance on CWI's person-centered approach to IEPs, community service assignments, reskilling and upskilling program jobseekers, and unsubsidized placement

Conducts annual programmatic and fiscal compliance monitoring

### IV. Funding

Each subgrant budget has four budget categories:

- 1. Participant Wages and Fringe Benefits (PWFB)
- 2. Administrative Costs (Adm)
- 3. Other Program Costs (OPC)
- 4. Nonfederal Share of Costs/Nonfederal Match

# Estimated Subgrant Budget

The subgrant award is for 12 months from July 1, 2025 – June 30, 2026

# V. Target Population (cont'd)

- Eligible jobseeker
- Priority of Service for Individuals with Multiple Barriers to Employment
- Individual Employment Plans (IEP)
- Unsubsidized Employment
- Community Service Work-Based Training

#### VI. Performance Measures

#### Measures while jobseeker is on SCSEP

- 1. Service level or number of eligible individuals served
- 2. Community Service Hours
- 3. Most-in-Need (MIN)

## VI. Performance Measures (cont'd)

#### <u>Measures after the job seeker exits –</u> <u> WIOA Common Measures</u>

- Exiters still employed in Q2 after Exit Exiters still employed in Q4 After Exit Median Earnings

Measures either when Jobseeker is enrolled or exited from SCSEP

- Participant Satisfaction
  Host Agency Satisfaction
  Employer Satisfaction

\*CWI's unsubsidized placement goal \*Spend 100% of subgrant funds by June 30th of each year

- Any 501(c)(3) non-profit organization
- Any government agency

#### That...

- Meet the goals, standards and policies of CWI for providing SCSEP, as described in this RFP
- Can serve the territory in this RFP

#### X. Evaluation Criteria

#### Proposals will be evaluated based on the following criteria:

- a. Organizational Capacity 25 points
- b. Program Design and Approach 40 points
- c. Administrative and Fiscal Qualifications 35 points
- Applicants must score a minimum of 70 points to be considered for funding.
- \*Review committee will be comprised of CWI staff.
- CWI reserves the right to seek additional information from Applicants, potentially including site visits or agency interviews.

#### XI. Notice of Award

- We will announce the contract award <u>no later than Monday</u>, <u>April 28, 2025</u>
- CWI will notify all applicants of decision by email
- CWI will facilitate transition activities of SCSEP in April and May 2025
